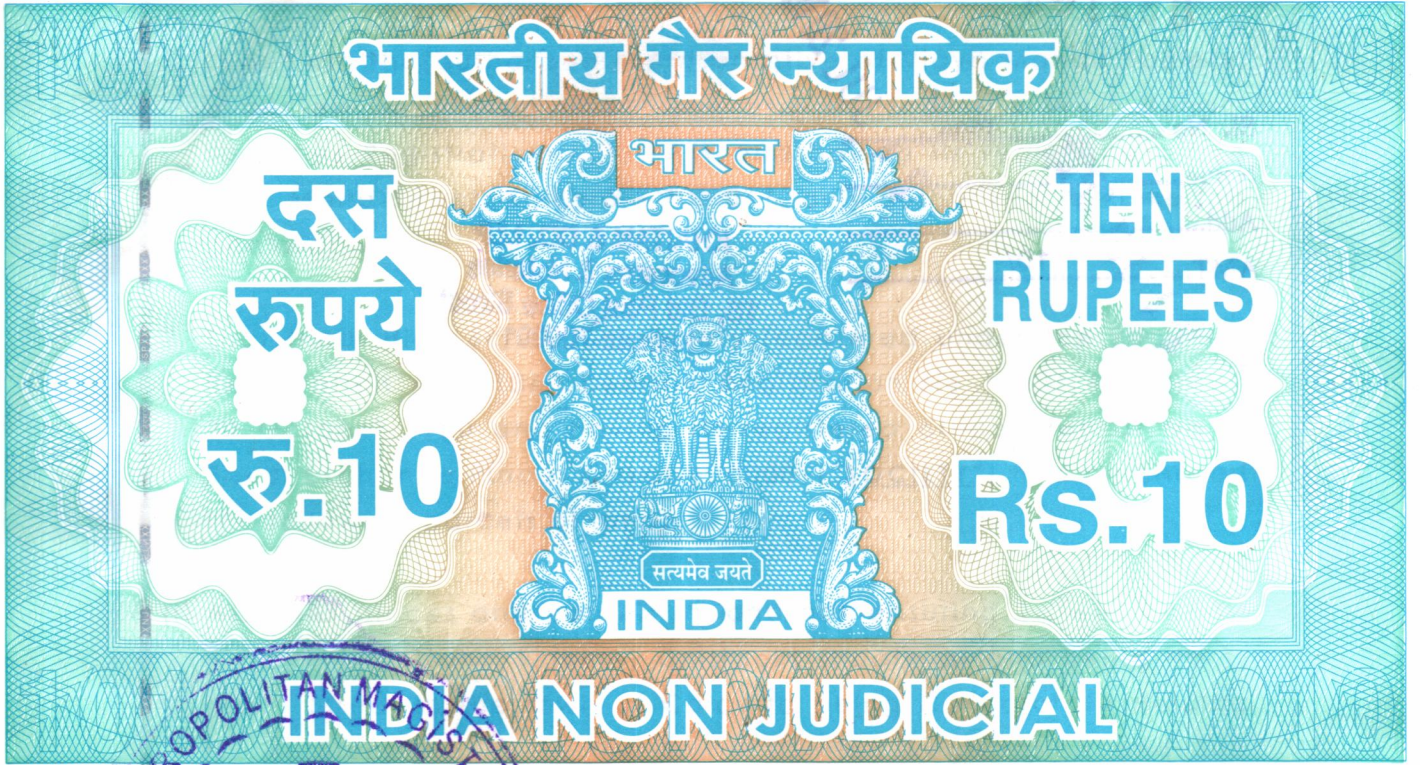

DECLARATION

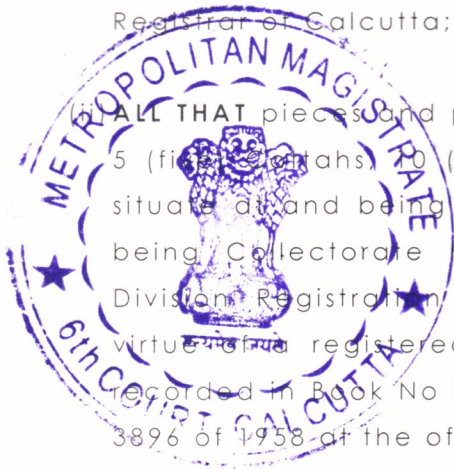
I, Virendra Nath Chaturvedi (Income Tax PAN - AASPC 0928P), son of Late Bhola Nath Chaturvedi, by faith: Hindu, by occupation: Secretary General, working for gain at Birla High School, 1, Moira Street, Kolkata - 700017, and residing at "Maruti Building" 12, Dr. U. N. Brahmachari Street, Kolkata, West Bengal- 700017, do hereby solemnly affirm and declare as follows:

*Meharim*

1. That I am the authorized representative of Vidya Mandir Society, a society registered under the provisions of the West Bengal Societies Registration Act, 1961 and having its registered office at 1, Moira Street, Kolkata – 700 017, duly authorized to make this declaration.

2. That Hindi High School, a society registered under the Societies Registration Act, 1860 bearing Registration No 19207/472 dated 30 October 1950 and having its registered office then at No 8, Royal Exchange Place, Kolkata-700001 ("**SOCIETY**") had purchased the following parcels of land:

(i) **ALL THAT** pieces and parcels of land admeasuring 2 (two) Bighas, 7 (seven) Cottahs, 9 (nine) Chittacks situate at and being No 1, Moira Street in the town of Calcutta being Collectorate Holding No 6, Block No XII in the South Division Registration and Sub Registration District Calcutta by virtue of a registered indenture made on 16 July 1953 and recorded in Book No I, Volume No 68, pages 110 to 116 being No 2605 of 1953 at the office of the Registrar of Calcutta; and



(ii) **ALL THAT** pieces and parcels of land admeasuring 2 (two) Bighas, 5 (five) Cottahs, 10 (ten) Chittacks and 12 (twelve) square feet situate at and being No 2, Moira Street in the town of Calcutta being Collectorate Holding No 5, Block No XII in the South Division Registration and Sub-registration District Calcutta by virtue of a registered indenture made, on 29 August 1958 and recorded in Book No I, Volume No 104, pages 162 to 69 being No 3896 of 1958 at the office of the Registrar of Calcutta.

3. That in memo No 307-RFS dated 26.07.2019 issued by the Registrar of Firms, Societies & Non-trading Corporations, West Bengal, it has been duly recorded that the Society was subsequently changed to 'VIDYA MANDIR SOCIETY' on 12 May 1973.

4. That Vidya Mandir Society is the sole and absolute owner of and is absolutely seized and possessed of and/or is well and sufficiently entitled to the parcels of land mentioned in

paragraphs 2(i) and 2(ii) above and Birla High School is located on the aforesaid parcels of land.
